Gentlemen,

first of all, we would like to express our gratitude for undertaking your visit to the Goldfield on behalf of the Foundation. Your investigation and report to the Board of Governors will decide on the course of action to be adopted for the delivery of the ship.

We are arranging to put you in funds to the extent of US\$1,000 to meet your travelling expenses and also a sum of US\$500 which should be handed to Mr. H. E. Ross, the acting purser, provided that he is willing to continue as such for at least the next leg of the journey.

If you telephone Mr. Ross in Acaphlco at 31769 when you arrive in Puerto Vallarta (see airline schedule attached) he will make arrangemente to travel with you to the ship and this may be valuable as he speaks fluent Spanish. We have undertaken to meet Ross's monthly salary but we believe that he has had some differences with the Capt. and is presently ashore. He has done nothing to displace our arrangements with him and he has been an invaluable source of information with regard to the ship since he joined it. If Capt. Brad Johnson's report arrives before your departure, I will provide you with a copy.

We feel that whatever funds have been sent to the ship will have been used and therefore whatever the estimated cost of bringing the ship home will have to be raised afresh.
